prohibited agreements – 8 decisions, in 4 of them violation is established

merger of enterprises – 13 decisions, in 1 of them are approved mergers under binding conditions, 1 decision of merger prohibition

Number of final decisions adopted by the Competition Council in 2016 divides in following groups:

abuse of dominant position – 2 decisions, in which a violation is established

prohibited agreements – 5 decisions, in 3 of them violation is established

merger of enterprises – 14 decisions, in 2 of them are notified cooperation agreements

procedural violations - 1 decision, where the undertaking was fined for irreversible deletion of information, thereby hindering the investigation of a case

prohibited agreements – 11 decisions, in 5 of them violation is established

merger of enterprises – 22 decisions, in 2 of them a violation is established (notification is not submitted before merger)

violation of the Code of Administrative Violations – 2 decision, where the undertaking was fined for the omission of information and the provision of false information.

merger of enterprises – 57 decisions, in 5 of them violation is established (notification is not submitted before merger), 2 decisions of merger prohibition

unfair competition – 7 decisions

possible violations of Advertising Law - 10 decisions, in 8 of them violation is established

Number of final decisions adopted by the Competition Council in 2007 divides in following groups:

abuse of dominant position – 13 decisions, in 2 of them violation is established

prohibited agreements – 12 decisions, in 5 of them violation is established

merger of enterprises – 82 decisions, in 3 of them violation is established (notification is not submitted before merger), 1 decision of merger prohibition

unfair competition – 18 decisions

possible violations of Advertising Law - 18 decisions, in 6 of them violation is established and 5 on imposition of a fine accordance with the Code of Administrative Violations

Number of final decisions adopted by the Competition Council in 2006 divides in following groups:


abuse of dominant position – 11 decisions, in 4 of them violation is established

prohibited agreements – 10 decisions, in 5 of them violation is established

merger of enterprises – 28 decisions, in 4 of them violation is established (notification is not submitted before merger)

unfair competition – 16 decisions, in 3 of them violation is established

possible violations of Advertising Law - 25 decisions, in 9 of them violation is established and 9 on imposition of a fine accordance with the Code of Administrative Violations
